

RESOLUTION #125

Whereas, it is desired to transfer monies from the various funds to the General Basic Fund and Rural Basic Fund, and

Whereas, said operating transfer is in accordance with section 331.432, Code of Iowa,

Now therefore, be it resolved by the Board of Supervisors of Mitchell County, Iowa, as follows:

Section 1. The balances of the following funds is ordered to be transferred to the appropriate funds, effective July 1, 1984.

From the Road Clearing Fund the amount of \$12,267.24 to the Rural Basic Fund.

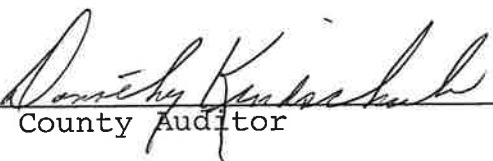
From the Weed Erad. Fund the amount of \$5876.89 to the Rural Basic Fund.
