

## Ordinance #16

AN ORDINANCE ADOPTING ALL EXISTING ORDINANCES IN ACCORDANCE WITH IOWA CODE SECTION 331.302(9). Mitchell County Ordinances are as follows:

Ordinance #1 Ordinance Adoption Procedure - adopted April 16, 1979

Ordinance #2 Mitchell County Planning and Zoning Ordinance – adopted November 3, 1980.

Ordinance #89 Ordinance establishing partial property tax exemption for industrial property upon which improvements have been made. Adopted February 17, 1982

Ordinance #90 Land subdivision regulations of Mitchell County. Adopted February 17, 1982

Ordinance #3 Liability of county jail prisoners. Adopted June 15, 1983

Ordinance #4 Destruction of noxious weeds and brush in public road right-of-way. Adopted April 2, 1984.

Ordinance #5 Establishing the Area Service System B road classification in Mitchell County. Adopted August 29, 1988

Ordinance #6 Adopting by reference the nonpublic water well rules for Mitchell County. Adopted June 4, 1990 *Amended 4-27-99*

Ordinance #7 Adopting the well abandonment standards for Mitchell County. Adopted June 4, 1990 *Amended 4-27-99*

Ordinance #8 Adopting by reference the on-site waste water disposal rules for Mitchell County Adopted June 4, 1990 *Amended 4-27-99*

Ordinance #9 Partial Property tax exemption for cattle facilities. Adopted December 17, 1990.

Ordinance #10 Established a policy for the separation of yard wastes from all other garbage and refuse. Adopted March 11, 1991.

Ordinance #11 Amends the Code of ordinances by adding a new chapter requiring persons that responsible for storing hazardous materials at their cost, clean up any leaks or spills of those materials and procedures. Adopted July 26, 1993.

Ordinance #12 Mandates the use of a rural address system for Mitchell County. Adopted November 8, 1993.

Ordinance #13 Established the local option sales and services tax in seven incorporated areas of Mitchell County. Adopted December 27, 1994.


Ordinance #14 Established a local option sales and services tax in the City of McIntire and the unincorporated areas of Mitchell County. Adopted April 10, 1995.

Ordinance #15 Established the policy and level of service in respect to clearance of snow or ice and maintenance of this county's secondary roads during the winter months. Adopted March 26, 1996.
