

PROCEEDINGS OF THE BOARD OF SUPERVISORS OF MITCHELL COUNTY, IOWA

Tuesday, November 10, 2009

The Board of Supervisors convened at 8:30 a.m. with Marreel and Voaklander present. Walk was driving school bus. Also present were: Charlie Pajer, Jerry Dunlay and Michelle Haacke (Media). Motion by Voaklander, second by Marreel to approve the agenda. All voted aye.

Discussed with County Attorney Mark Walk deferred compensation and county roads. Also discussed the new Osage Public Safety Center.

Supervisor Walk arrived at 8:45 a.m.

County Engineer Jim Hyde and Assistant Engineer Rich Brumm reported that the paving project, painting of white lines and blading of roads is continuing. After discussion, motion by Voaklander, second by Walk to approve Resolution #764-09 to erect a stop sign at the intersection of Red Ball Road and Kirkwood Avenue. Roll call vote: all ayes.

CPC Director Bob Lincoln gave an update for the Care Facility. An inspection of the building will be scheduled in the next few weeks.

Sheriff Curt Younker reviewed the Sheriff report for October. Motion by Walk, second by Voaklander to approve the report in the amount of \$28,232.58. Roll call vote: all ayes.

Motion by Voaklander, second by Walk to approve the minutes of the November 3rd meeting as amended. Roll call vote: All ayes.

Motion by Voaklander, second by Walk to approve the claims. Roll call vote: all ayes.

Items of note: Walk reported on the NIACOG meeting, Voaklander reported on the FMC Landfill meeting and Marreel reported on the FMC Empowerment meeting. Received the October Clerk of Court report in the amount of \$1,425.11.
