AGREEMENT FOR THE JOINT
EXERCISE OF GOVERNMENTAL POWERS
PURSUANT TO CHAPTER 28E (1988)

Introduction

1. This agreement is entered into pursuant to Iowa Code Chapter 28E (1988), providing that any public agency of this state may enter into an agreement with one or more public or private agencies for joint or cooperative action.

Parties

2. The counties of Chickasaw, Hardin,
Benton, Fayette, Mitchell,
Cedar, Decatur, Mahaska,
Tama, and Van Buren constitute "public
agencies" under Iowa Code Chapter 28E.2 (1988).

Specifications

3. PURPOSE. The purpose of this agreement is to provide for the joint exercise of powers and cooperative action between the above parties in order to provide workers' compensation insurance coverage for the employees of the parties.

4. ADMINISTRATOR. All workers' compensation services will be administered by the chairperson of the Heartland Insurance Risk Pool.

5. MANNER OF FINANCING. The parties shall share the cost of the workers compensation insurance coverage as agreed to by the parties.

6. MANNER OF ACQUIRING, HOLDING AND DISPOSING OF FUNDS.

The parties state they do not intend to acquire or hold any real or personal property to be used in this joint undertaking.

8. TERMINATION. Each party to this agreement may terminate its participation pursuant to the termination provisions of the Heartland Insurance Risk Pool Agreement.

9. OTHER MATTERS. This agreement shall be filed with the Secretary of State, State of Iowa, and recorded with each county's recorder.

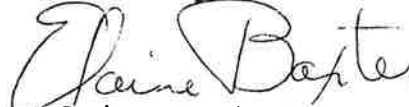
