RESOLUTION TO SET TIME AND DATE FOR HEARING  
CONSIDERATION OF ORDINANCE #6 ADOPTING NON-PUBLIC WATER  
WELL RULES, ORDINANCE #7 ADOPTING WELL ABANDONMENT STANDARDS  
AND ORDINANCE # 8 ADOPTING ON-SITE WASTE WATER DISPOSAL RULES.

MITCHELL COUNTY ORDINANCE #6

An Ordinance adopting by reference the nonpublic water well  
rules of Iowa Administrative Code (Chapter 49), for Mitchell  
County, Iowa.

WHEREAS, the State of Iowa has enacted legislation setting the  
contruction standards for nonpublic water wells in the State,  
and,

WHEREAS, the Iowa Department of Natural Resources has adopted  
rules to implement the said statutory provisions,

BE IT ENACTED by the Board of Supervisors of Mitchell County,  
Iowa; that said Chapter 49 of Iowa Administrative Code in its  
entirety shall hence forth be the nonpublic water well rules  
of Mitchell County.

MITCHELL COUNTY ORDINANCE #7

An ordinance adopting by reference the well abandonment  
standards of the Iowa Administrative Code (Chapter 39), for  
Mitchell County, Iowa.

WHEREAS, the State of Iowa has enacted legislation setting standards  
for properly plugging abandoned wells in the State, and

WHEREAS, the Iowa Department of Natural Resources has adopted  
rules to implement the said statutory provisions,

BE IT ENACTED by the Board of Supervisors of Mitchell County,  
Iowa; that the said Chapter 39 of Iowa Administrative Code  
in its entirety shall henceforth be the well abandonment standards  
of Mitchell County.

MITCHELL COUNTY ORDINANCE #8

An ordinance adopting by reference the on-site waste water disposal rules of the Iowa Administrative Code (Chapter 69), for Mitchell County, Iowa.

WHEREAS, the State of Iowa has enacted legislation setting the construction standards for on-site waste water disposal in the state, and

WHEREAS, the Iowa Department of Natural Resources has adopted rules to implement the said statutory provisions,

BE IT ENACTED by the Board of Supervisors of Mitchell County, Iowa that the said Chapter 69 of the Iowa Administrative Code in its entirety shall henceforth be the on-site waste water disposal rules of Mitchell County.
