

RESOLUTION #257-92

ELECTION PRECINCTS IN MITCHELL COUNTY

WHEREAS, Section 49.3 and 49.4 require that election precincts shall be drawn by County Board of Supervisors. No precinct shall have a total population in excess of three thousand five hundred (3500) as shown by the most recent federal decennial census.

WHEREAS, each precinct is contained wholly within an existing legislative district and

WHEREAS, each precinct follows supervisor district boundaries as required according to the Code of Iowa,

THEREFORE, BE IT RESOLVED BY THE Supervisors of Mitchell County, Iowa that the election precincts are as follows:
