NOW THEREFORE BE IT RESOLVED by Mitchell County that said part of present right-of-way herein described, together with any and all rights of Mitchell County in and to the same are hereby abandoned, and Mitchell County hereby disclaims any right, title or interest in and to said part of present right-of-way or to the use thereof for any purposes whatsoever.

Any person owning land abutting on the road which is proposed to be closed has the right to file, in writing, a claim for damages at any time on or before the date fixed for hearing. The failure to file such a claim will result in a forfeiture of any claim for damages.
