

## PROCEEDINGS OF THE BOARD OF SUPERVISORS OF MITCHELL COUNTY, IOWA

Tuesday, January 27, 2026

The Board of Supervisors convened at 8:30 a.m. with all members present. Also, present were Amanda Baer, Shannon Paulus, Laura Huisman, Greg Beaver, Aaron Murphy, Rich Brumm, Mike Miner, Penney Morse, Tom Rolfes, Alex Schmidt, Keith Horgen, Rebekah Barr, and Guadalupe Bandillo. The meeting was made available by video via "Go to Meeting". Motion by Marzen, second by Hartogh to approve the agenda with switching items #10 Discussion & Possible Action on General Budget and #12 Consideration of Compensation Board Salary Recommendations for FY 26/27. All voted aye.

Motion by Hartogh, second by Hendrickson to approve the minutes of the January 20<sup>th</sup> meetings & claims. Roll call: all voted aye.

County Attorney Murphy was not available.

County Sheriff Beaver had nothing to present.

Amanda Baer provided an update from the Planning & Zoning Board of Adjustment meeting with Simple Mining.

County Engineer Rich Brumm has done some interviews and plans to make a couple of offers. Last week, secondary roads were short a truck. Motion by Hartogh, second by Wherry to approve Resolution #1347-26 for Emergency Closure of Any Road for Maintenance Purposes. Roll call vote: all voted aye.

Motion by Marzen, second by Hendrickson to approve participating in ISAC Wellness Program. Roll call vote: all voted aye. Shannon Paulus would like to have an incentive for the employees on the wellness committee.

Motion by Hartogh, second by Marzen to approve 2025 Gross Wage Report. Roll call vote: all voted aye.

Motion by Wherry, second by Hartogh to approve Mike Galloway with Ahler's as the new Union Rep. Roll call vote: all voted aye.

Motion by Hendrickson, second by Wherry to approve Resolution #1348-26 Compensation Board Recommendation. Roll call vote: all voted aye.

Motion by Wherry, second by Frein to approve \$0.90 wage increase for remaining employees, deputies are under elected officials, and 3% based on safety coordinator current wage. Roll call vote: Frein, Hendrickson, Marzen, Wherry ayes, Hartogh nay.

Motion by Marzen, second by Hendrickson to table action on general budget until there's an opportunity to review the changes. There was discussion on contributing to Elderbridge the same amount as the current year as they don't serve the Seminary anymore. Wherry would like to have Amanda's wages be the same for both departments. It was noted care of graves is budgeted at \$7,000 and Mitchell Soil & Water Conservation District is budgeted at \$3,500. Roll call vote: all voted aye.

Hartogh reported on FMC Landfill, Frein reported on FMC DECAT, Hendrickson reported on County Social Services, and Heartland Insurance, and Marzen reported on Central Iowa Juvenile Detention. Wherry had nothing to report. Penney Morse thanked the board for being a public servant, and

reminded the board only the first two counties that approved the pipeline ordinance has been sued. Keith Horgen asked if the County still supported spec building funding. The board confirmed that MCEDC does fund those projects.
