

PROCEEDINGS OF THE BOARD OF SUPERVISORS OF MITCHELL COUNTY, IOWA

Tuesday, May 12, 2026

The Board of Supervisors convened at 8:30 a.m. with all members present. Also, present were Brandon Halsne, Greg Beaver, Justin Trees, Rich Brumm, Tom Rolfes, Jenny Backer, Keith Horgen, John Walker, Judi Hamaker, Veronica Kurtz, & Bailey Cotter. The meeting was made available by video via "Go to Meeting". Motion by Hartogh, second by Wherry to approve the agenda. All voted aye.

Motion by Marzen, second by Hendrickson to approve the minutes of the May 5th meeting & claims. Roll call: all voted aye.

County Attorney Murphy was not available.

County Sheriff Beaver presented his fees collected in April in the amount of \$11,485.47. Motion by Hartogh, second by Wherry to approve the Sheriff's Report for April. Roll call vote: all voted aye. Beaver said the flooring is done in dispatch. Deputy Trees will have an update next week on the positions available at the Sheriff's Office.

There was no department head discussion.

County Engineer Rich Brumm had quotes for the annual paint needed that will be split with Worth County, with Mitchell County's being roughly \$80,000. Engineer Brumm went through possible bridges that will qualify for the grant, with a deadline of June 8th. There is a \$10,000 grant fee.

Motion by Hartogh, second by Marzen to approve Liquor License for Sunny Brae Golf & Country Club. Roll call vote: all voted aye.

Motion by Hendrickson, second by Wherry to approve Contract with Cost Advisory Services. Roll call vote: all voted aye.

Judi Hamaker and Veronica Kurtz went over the Heartland Insurance Renewal. Veronica went over the premiums for the current fiscal year and proposed fiscal year. Judi discussed the sexual harassment training will have two times available if needed. The Heartland Fall Seminar is scheduled for September 10th in Toledo. November 13th will be the newly elected officials training. Motion by Marzen, second by Hartogh to approve Heartland Insurance Renewal pending updates to equipment breakdown and keeping the liability limit at \$5 million. Roll call vote: all voted aye.

Wherry reported on NIACOG, Frein reported on Fair Board, and Hendrickson reported on Heartland Insurance. Hartogh and Marzen had nothing to report. Laura Huisman available "Go to Meeting" stated the Mental Health Walk will be held this Thursday, May 14th, starting at the Public Health Building at noon. John Walker thanked the board for the details on keeping the County running, and shared concerns about Bitcoin, pipelines, and data centers.
