

PROCEEDINGS OF THE BOARD OF SUPERVISORS OF MITCHELL COUNTY, IOWA

Tuesday, May 26, 2026

The Board of Supervisors convened at 8:30 a.m. with Frein, Wherry, Marzen, and Hendrickson present. Hartogh was available via “Go to Meeting”. Also, present were Aaron Murphy, Justin Trees, Tom Rolfes, Jenny Backer, and Ashlie Sveum. The meeting was made available by video via “Go to Meeting”. Motion by Marzen, second by Hendrickson to approve the agenda. All voted aye.

Motion by Hendrickson, second by Wherry to approve the minutes of the May 19th meeting & claims. Roll call: all voted aye.

County Attorney Murphy had nothing to discuss.

County Deputy Sheriff Trees said the jail certification was done on May 13th and everything complied. May 28th Senator Grassley will be in Stacyville, and May 30th Zach Lehn is planning to be in Osage, the Sheriff’s Office will be providing security both days.

Auditor Foster stated next week’s meeting will be on Monday with the election being Tuesday. Supervisor Marzen stated the event at the fairgrounds doubled in performance from last year.

County Engineer Rich Brumm was not available. Supervisor Frein read an email from Brumm giving an update on Addison Avenue, the rock map will get sent out, and Brumm will be submitting qualified bridges for the grant.

There was discussion on which route to take with the cupola issue. Consensus of the board is to have Attorney Murphy reach out to Joe Gamble to see what his opinion is. Supervisor Hendrickson will reach out to a local contractor to see if a local contractor is interested in a quote to fix the cupola.

Wherry reported on Mitchell Soil & Water, Frein reported on FMC-ECI and FMC-DECAT, and Marzen reported on North Iowa Community Action Commission. Hartogh and Hendrickson had nothing to report. There were no public comments.
