# PROCEEDINGS OF THE BOARD OF SUPERVISORS OF MITCHELL COUNTY, IOWA

## Tuesday, June 11, 2024

The Board of Supervisors convened at 8:30 a.m. with Frein, Wherry, Mayer, and Hendrickson present. Also, present were Trystan Dohlman, Jerry Reshetar, Tom Rolfes, Jenny Backer, Ashley Rosendahl, Megan Taets, Rich Brumm, Ryan Stephen, Keith Horgen, Shannon Paulus, and Lindsay Uhlenhopp. The meeting was made available by video via "Go to Meeting". Motion by Wherry, second by Frein to approve the agenda. All voted aye.

Motion by Mayer, second by Wherry to approve the minutes of the June 3<sup>rd</sup> meeting and claims. Roll call vote: Wherry, Mayer, and Hendrickson ayes, Frein abstained.

County Attorney Murphy was not available.

County Sheriff Beaver was not available.

Auditor Foster stated campaign signs can stay up as long as there is no city or county ordinance against them.

County Engineer Rich Brumm plans to put in some truck bids in the next month. Brumm wants to have the mechanics review the specs to ensure the truck has what Secondary Roads need. Engineer Brumm received a rock run quote from Falk's for 64,800 ton for \$1,029,784. Motion by Wherry, second by Frein to approve the Falk rock run quote. Roll call vote: all voted aye. Brumm explained the paint quote which includes Worth County, City of Saint Ansgar and City of Northwood. Motion by Wherry, second by Mayer to approve the paint quote for \$111,706.50. Roll call vote: all voted aye.

Motion by Mayer, second by Frein to approve Treasurer's Monthly Report for May in the amount of \$1,991,767.88. Roll call vote: all voted aye. Shannon Paulus stated the tax sale is happening next Monday. The Treasurer's Office will be closed on Thursday, June 20, 2024, for Iowa DOT training.

Motion by Frein, second by Mayer to approve Recorder's Monthly Report for May in the amount of \$8,133.20. Roll call vote: all voted aye.

Megan Taets discussed Angela Nasstrom has resigned as the Mitchell County and Cerro Gordo County mental health advocate. Ashley Rosendahl and Taets will check with Howard and Floyd counties if their mental health advocate would be interested in taking over Mitchell County. Taets explained HF 2673 and how the state will be dividing counties up into seven behavior health districts.

Wherry reported on CSS Counselor Meeting, and Frein reported on Fair Board. Mayer and Hendrickson had nothing to report. Received manure management plan updates from Happy Pork Inc, and Double K Farming. There were no public comments.
