

PROCEEDINGS OF THE BOARD OF SUPERVISORS OF MITCHELL COUNTY, IOWA

Monday, November 3, 2025

The Board of Supervisors convened at 8:30 a.m. with Frein, Wherry, Marzen, and Hendrickson present. Hartogh was available via “Go to Meeting”. The meeting was made available by video via “Go to Meeting”. Also present were Max Brandau, Rich Brumm, Tom Rolfes, Jenny Backer, Deb Freeman, Amand Baer, Jon Walker. Motion by Marzen, second by Hartogh to approve the agenda with moving item 3a Approval of Plans for Addison Avenue Resurfacing, FM-C066(91)- -55-66 to item 6a. All voted aye.

Motion by Hendrickson, second by Wherry to approve the minutes of the October 28th meeting. Roll call vote: all voted aye.

County Attorney Murphy was not available.

County Sheriff Beaver was not available.

Supervisor Hendrickson asked if we needed to appoint the Osage Oracle as the paper replacing the Mitchell County Press News.

County Engineer Rich Brumm provided an update on the bridge south of McIntire. Motion by Wherry, second by Marzen to approve Addison Avenue Resurfacing, FM-C066(91)- -55-66. Roll call vote: all voted aye.

Motion by Hendrickson, second by Wherry to approve CLP Application for Nathan Zuehl for \$20,000. Roll call vote: all voted aye.

Motion by Marzen, second by Hartogh to reappoint Theresa Boerjan to the Planning & Zoning Board of Adjustment. Roll call vote: all voted aye.

There was discussion on ISAC’s Amicus Curiae Brief Support. Supervisor Hartogh suggested ISAC follow the same guidelines as any other entity requesting funding. Motion by Marzen, second by Hendrickson to approve ISAC Amicus Curiae Brief Support for \$500. Roll call vote: Wherry, Frein, Hartogh nay, Hendrickson, Marzen aye.

Marzen reported on ISAC Webinar, and Mitchell County Substance Abuse Coalition, Hendrickson reported on ISAC Webinar and Iowa Workforce Development, and Frein reported on FMC Early Childhood. Wherry and Hartogh had nothing to report. Deb Feeman and Lisa Ritzert stated the ISAC webinar is still available for view on their website and they suggest the board revisit to try and keep local control. Jon Walker shared similar concerns and stated this is just a foreshadow of things to come. Supervisor Marzen plans to make a personal contribution to ISAC.
