

## PROCEEDINGS OF THE BOARD OF SUPERVISORS OF MITCHELL COUNTY, IOWA

Tuesday, December 23, 2025

The Board of Supervisors convened at 8:30 a.m. with all members present. The meeting was made available by video via "Go to Meeting". Also present were Amanda Baer, Lindsey Falk, Keith Horgen, Rich Brumm, Tom Rolfes, Brandon Halsne, Mike Miner, Greg Beaver, and Aaron Murphy. Motion by Marzen, second by Frein to approve the agenda. All voted aye.

Motion by Hendrickson, second by Wherry to approve the minutes of the December 16<sup>th</sup> meeting & claims. Roll call vote: all voted aye.

County Attorney Murphy had nothing to discuss.

County Sheriff Beaver had nothing to discuss.

Mike Miner provided an update after the Conservation Board meeting last week. Pay app #5 for Water Trail was paid, with T-38 and Bennett Access are wrapped up. The board went over purchasing two new trucks and selling the two they would be replacing, discussed the Deer & Turkey Show, cabin work being done at the Pitzen Cabin and Conservation is working on filing Annual Reports. Conservation district meeting will be held on January 14<sup>th</sup> in Mitchell County. Supervisor Marzen stated Sandy Offen and Brenda Miller's terms are up on Board of Health. Miller is not looking to renew her position.

County Engineer Rich Brumm tested out a used truck last week and it is not going to work for what they need. Brumm plans to purchase the other used truck from Conservation. The Board agreed to purchasing a second truck with the money in the budget already.

Supervisor Marzen explained there was an update to the food area of the general assistance policy. Motion by Marzen, second by Wherry to approve General Assistance Policy. Roll call vote: all voted aye.

Mike Miner provided the Conservation Annual Report. Conservation purchased Historic Oaks Wildlife Area, earned 3<sup>rd</sup> Place in the Izaak Walton Wildlife Habitat Improvement Award, completed essential repairs to the hydro facility, and made meaningful progress.

Motion by Frein, second by Hendrickson to approve Liquor License for Osage Bowl & Rivals Sports Bar & Grill. Roll call vote: all voted aye.

Jenny Backer was available via "Go to Meeting" to discuss replacing Nathan Kinter on the Mitchell County Economic Development Commission. Motion by Hendrickson, second by Wherry to approve Christina Hubka as the representative for the City of Riceville to the Mitchell County Economic Development Commission. Roll call vote: all voted aye.

The minutes have not been received from the Compensation Board. The Compensation Board recommended 3% salary increases for Auditor, Recorder, Treasurer, County Attorney, Sheriff, and 0% increase for Board of Supervisors with \$1,500 per year for chairperson. The Board of Supervisors would like to wait for the official minutes from the Compensation Board.

The Board of Supervisors would like departments to fill out wages as is on their budget worksheets. Mike Miner stated Conservation Board approves wages, so the board will see salary increases on their budget. Departments also need to highlight line items that have over a 2% increase.

Motion by Marzen, second by Wherry to approve Clerk of Court Report for November in the amount of \$1,042.33. Roll call vote: all voted aye.

Wherry reported on Mitchell County Soil & Water District, and Executive NIACOG, Marzen reported on Mitchell County Substance Abuse Coalition, and Board of Health, Hendrickson reported on Safety Meeting, and Frein reported on FMC-DECAT. There were no public comments.
