

PROCEEDINGS OF THE BOARD OF SUPERVISORS OF MITCHELL COUNTY, IOWA

Tuesday, May 27, 2025

The Board of Supervisors convened at 8:30 a.m. with Frein, Wherry, Marzen, and Hendrickson present. The meeting was made available by video via “Go to Meeting”. Also present were Ryan Stephen, Tom Rolfes, Dean Betts, Jenny Backer, Vince Morische, Amanda Baer and Keith Horgen. Motion by Wherry, second by Marzen to approve the agenda. All voted aye.

Motion by Hendrickson, second by Marzen to approve the minutes of the May 20<sup>th</sup> meetings & claims. Roll call vote: all voted aye.

County Attorney Murphy was not available.

County Sheriff Beaver was not available.

There was no department head discussion.

County Engineer Rich Brumm was not available.

Motion by Hendrickson, second by Wherry to appoint Vince Morische to the Planning & Zoning Board of Adjustment. Roll call vote: all voted aye.

There was discussion on a security light in New Haven that is currently not billed to any account. The previous neighbor did not want to pay for the light; however, the new owner will pay for the light. Motion by Marzen, second by Wherry to reply to Alliant to leave the light pole in if the owner next to it will pay. Roll call vote: all voted aye.

Keith Horgen stated the City of St. Ansgar opted out of the 28E agreement for MCEDC, which will cut some of the benefits. Horgen suggested not forgetting about economic development for around St. Ansgar. Jenny Backer stated at MCEDC meeting next week they will review the different programs that may continue.
