## PROCEEDINGS OF THE BOARD OF SUPERVISORS OF MITCHELL COUNTY, IOWA

Tuesday, August 12, 2025

The Board of Supervisors convened at 8:30 a.m. with all members present. The meeting was made available by video via "Go to Meeting". Also present were Greg Beaver, Aaron Murphy, Rich Brumm, Keith Horgen, Jenny Backer, Ryan Stephen, and Amanda Baer. Motion by Marzen, second by Frein to approve the agenda. All voted aye.

Motion by Hendrickson, second by Wherry to approve the minutes of the August 5<sup>th</sup> & August 8<sup>th</sup> meetings & claims. Roll call vote: all voted aye.

County Attorney Murphy prepared the resolution to terminate the moratorium.

County Sheriff Beaver presented his fees collected in July in the amount of \$30, 444.21. Motion by Wherry, second by Marzen to approve the Sheriff's Report for July. Roll call vote: all voted aye. Sheriff Beaver wanted clarification on the new wage scale. Supervisor Marzen explained how accrual works for government. Beaver believes his staff is being shorted by being paid at daily rates. Auditor Foster will contact Ann at Ahler's for clarification on how to pay overtime to salaried employees. Sheriff Beaver has spoke with Mayor Horgen about having law enforcement coverage if their chief police officer retires.

Jenny Backer discussed Fox River Mills officially closing and moving to North Carolina. They plan to keep sixteen employees and are looking for a building to house those employees. The current building is owned by a third party and Backer will be meeting with real estate about getting the building to be listed.

County Engineer Rich Brumm provided an update on the bridge south of McIntire. Brumm also provided an update on the truck route around Osage.

Motion by Wherry, second by Frein to approve Resolution #1307-25 to end Moratorium. Roll call vote: all voted aye.

Supervisor Marzen stated if the possible amendments were mistakes made by NIACOG, the Board can send the publication fees to NIACOG to pay. Motion by Marzen, second by Wherry to approve sending Ordinance 62 to the Mitchell County Zoning Commission for possible amendments. Roll call vote: Frein, Wherry, Hartogh, Marzen ayes, Hendrickson nays.

If an ordinance is created, it is done by the Planning & Zoning Commission. Planning & Zoning Board of Adjustment handles items like a conditional use permit. When talking about Solar Ordinance, the zoning commission would need to meet. The board of adjustment is welcome to attend and collaborate. Motion by Wherry, second by Marzen to approve Planning & Zoning Director to contact the Zoning Commission to begin the process of developing a proposed solar ordinance. Roll call vote: Hartogh, Frein, Wherry, Marzen ayes, Hendrickson nay.

Motion by Frein, second by Hendrickson to approve Treasurer's Report for July in the amount of \$1,171,664.07. Roll call vote: all voted aye.

Motin by Marzen, second by Wherry to approve Recorder's Report for July in the amount of \$7,297.82. Roll call vote: all voted aye.

Motion by Hendrickson, second by Marzen to approve Fireworks Permit for Russ Nelson. Roll call vote: all voted aye.

Motion by Hendrickson, second by Frein to approve Resolution #1308-25 Contract for Services for St. Ansgar Heritage Museum & History Center in the amount of \$4,000. Roll call vote: all voted aye.

Motion by Marzen, second by Hendrickson to approve Resolution #1309-25 Contract for Services for Meyer Historical Society in the amount of \$500. Roll call vote: all voted aye.

Motin by Frein, second by Marzen to approve Liquor License for Meyer Historical Society, INC. Roll call vote: all voted aye.

Wherry reported on Osage City Council, Stacyville City Council, and Mitchell City Council to present possible Urban Renewal Plan Amendments, Hartogh reported on FMC Landfill, and Marzen reported on Stacyville City Council for possible Urban Renewal Plan Amendments. Hendrickson and Frein had nothing to report. Received manure management plan updates from Primrose Sow/Litter, Shadow Finisher Farm, Anderson Finisher Farm, Byrnes Site, Riceville Site, Hogville Corp Site, Groth Farms, Blong North Finisher Farm, and Junction South. Keith Horgen stated NIACOG is a good economic option, there is not an attorney involved, and they can give suggestions and let boards decide. NIACOG is stretched very thin right now.
