

## PROCEEDINGS OF THE BOARD OF SUPERVISORS OF MITCHELL COUNTY, IOWA

Monday, November 9, 2020

The Board of Supervisors convened at 8:30 a.m. with all members present. Also present were Chuck Pajer, Samantha Scharper, Bruce Biederman, Jim Wherry, Mike Mayer, and Tony Stonecypher. Steve Thompson was present from the Media. Due to the COVID 19 the meeting was made available by video via "Go to Meeting". Motion by Smolik, second by Walk to approve the agenda. All voted aye.

Motion by Walk, second by Smolik to approve the minutes of the November 3rd meeting and the claims. All voted aye.

Discussed with County Attorney Mark Walk a possible county wide ordinance regarding the public wearing masks due to the increase of COVID cases in Mitchell County. Mark stated that the Governor would have to enact an Emergency Proclamation. Mark also said that the Iowa Attorney General's office doesn't agree at this time. Supervisor Walk would rather the BOS approve a Resolution that would strongly suggest the public wear masks.

Sheriff Greg Beaver gave an update for the jail.

County Engineer Rich Brumm stated that some of his employees are being tested for COVID and for safety reasons he is isolating at home.

Items of note: Francis reported on the Iowa Workforce Development meeting. Mike Mayer asked about the status of the Russ Kephart case.

Motion by Francis, second by Walk to approve reappointing Jolene Norby to a 3 year-term on the Board of Health. All voted aye.

Motion by Francis, second by Smolik to approve reappointing Jean Brumm, Leo Jordan and Kurt Meyer to a 6 year-term on the Judicial Magistrate Appointing Commission. All voted aye.
