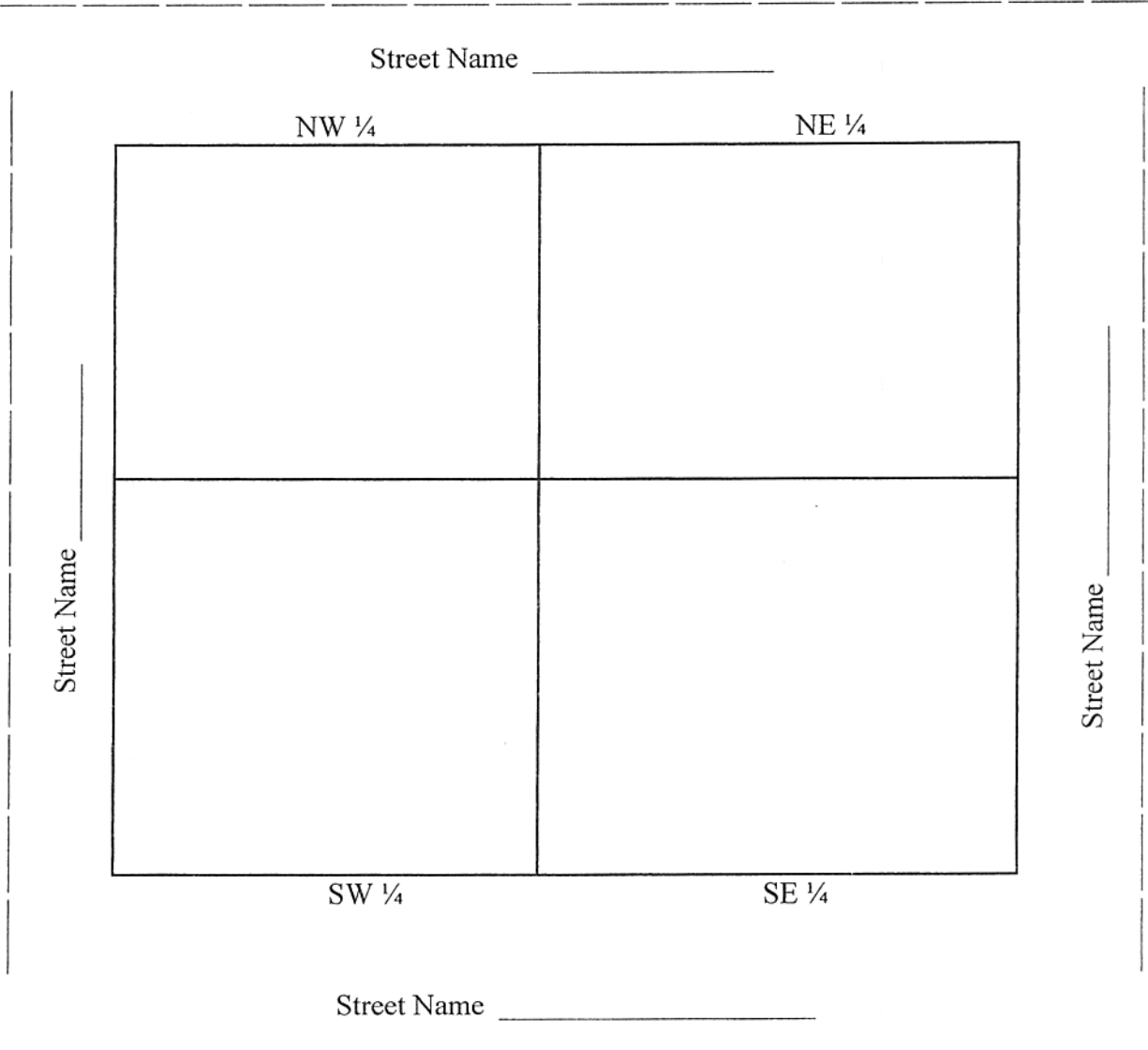

## Driveway Policy Main Points

Complete details in "Road Access Policy"

Applications-	-obtained through approved contractor -contractor reviews job for requirements -contractor may start job when application is completed -contractor sends application to engineers office
Culvert -	-galvanized corrugated metal or -dual wall corrugated polyethylene plastic
Drainage -	-adequate for site -minimum 15 inch
Driving Width -	-minimum 24 foot -maximum 40 foot
Placement -	-sod shall be removed so culvert lays flat on ditch bottom (do not place on top of sod) -culvert shall be placed as far to back side of ditch as possible (not center of ditch)
Fill Material -	-earth (broken concrete or field stone not acceptable) -minimum 2 foot cover over pipe
Location -	-200' minimum separation distance from an adjacent intersection -measure is center of adjacent road to center of proposed driveway
Slopes -	-2-1 slopes -6-1 slopes piped -10-1 slopes no pipe -gravel roads -hard surface roads -hard surface roads
Extending Existing Drives -	-new culvert will match existing pipe diameter -only manufacturer recommended jointing methods shall be allowed -an overlap is required at the culvert/band/pipe connection
Surface Rock -	-applicant is responsible
Variances -	-appeals reviewed at regularly scheduled Board of Supervisor meetings
Non-Compliance -	-Not meeting these standards drive will be removed at owners expense.
